**Authorization for Payment of Fees – Electronic Bank Draft or Credit/Debit Card**

I authorize Old Course Sauk Centre, LLC "Course" and the financial institution or credit card company named above to deduct the amount of my membership fee from the account identified above. Early termination will only be accepted in the event of a member who passes away or a member who has accepted a military assignment out of the area. **A \$30.00 return fee will be charged for each returned bank draft or declined credit card (i.e. Revocations, Closed Accounts & Non-Sufficient Funds).**
